Subject: Consideration of compliance verification assessment report with regard to Continuance of Recognition of MBBS degree granted by Kannur University in respect of students being trained at Academy of Medical Sciences, Kannur.

Sir/Madam,

I am directed to inform that the compliance verification assessment of the physical and the other teaching facilities available for continuance of recognition of MBBS degree granted by Kannur University in respect of students being trained at Academy of Medical Sciences, Kannur was carried out by the Council's assessors on 10th July, 2018. The said assessment report alongwith Photographs/Videography, previous assessment reports (07th February, 2018, 14th September, 2017, 9th May, 2017 and 27th & 28th July, 2016) was considered by the Executive Committee at its meeting held on 07.08.2018 and it was decided as under:-

"The Executive Committee of the Council considered the compliance verification assessment report (10thJuly, 2018) alongwith Photographs/Videography, previous assessment reports (07th February, 2018, 14th September, 2017, 9th May, 2017 and 27th& 28th July, 2016) and decided to revoke the decision of application of clause 8(3)(1)(c) of Establishment of Medical College Regulation (Amendment),2010(Part II), dated 16th April, 2010.

The Executive Committee further recommended that recognition of MBBS degree granted by Kannur University in respect of students being trained at Academy of Medical Sciences, Kannur be continued restricting the number of admission to 100 (One Hundred) students.

The Executive Committee further decided that the attention of the institute be drawn to Sections 8(3)(2), 8(3)(3) & 8(3)(4) of the Establishment of Medical Colleges Regulations (Amendment), 2010 (Part II) dated 16th April,2010 and act accordingly at appropriate time, which reads as under:-

8 (3) ...

(2) The recognition so granted to an Undergraduate Course for award of degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.

(3) The procedure for 'Renewal' of recognition shall be same as applicable for the

award of recognition.

(4) Failure to seek timely renewal of recognition as required in sub clause (a) supra shall invariably result in stoppage of admissions to the concerned Undergraduate Course of MBBS at the said institute."

The above decision of the Executive Committee has been approved by the Oversight Committee on 31.08.2018.
